Hoskins, MD</p>	<p data-bbox="739 204 1955 394">Dr. Iffath Abbasi Hoskins is the current president of the American College of Obstetricians and Gynecologists, Clinical Professor and Director of Patient Safety in the Department of Obstetrics and Gynecology at New York University (NYU) School of Medicine. She is a Maternal Fetal Medicine subspecialist. Dr. Hoskins served 29 years with the U.S. Navy and Marine Corps, achieving the rank of Captain/Colonel.</p> <p data-bbox="739 443 1986 591">Dr. Hoskins completed a Maternal Fetal Medicine (MFM) Fellowship at the Uniformed Services University of the Health Sciences (USUHS) in Bethesda, MD. Following that, she was an MFM Attending at USUHS and Co-Director of the Medical Genetics Fellowship at National Institutes of Health.</p> <p data-bbox="739 639 1982 787">As an ACOG Fellow, Dr. Hoskins has held several leadership positions at the national level, including on the Board of Directors, and in Committees and Task Forces. She has represented ACOG in the American Medical Association, American College of Surgeons, and American Academy of Pediatrics.</p> <p data-bbox="739 836 1982 914">Dr. Hoskins' Presidential Initiative is Minding Mental Health which is aimed at improving the mental health of patients in the peripartum period and in later life.</p>

Manning Chair of the Department of Obstetrics & Gynecology</i>, and Professor of Ob/Gyn, Pediatrics, Psychiatry and Population & Quantitative Health Sciences at UMass Chan Medical School/UMassMemorial Health. She is an academic specialist in general Ob/Gyn, physician-scientist, educator, advocate, and leader.</p> <p data-bbox="739 1144 1986 1292">Dr. Moore Simas is MPI of the Lifeline for Moms National Network of Access Programs, designed to facilitate peer-learning and sharing of resources with partners and collaborators, across the U.S., and to facilitate quality improvement and program evaluation within and across Access Programs.</p> <p data-bbox="739 1341 1982 1489">Dr. Moore Simas has a long-standing federally funded research portfolio through CDC, NIH, PCORI, ACOG, Perigee and other foundations, and is an author on well-over 100 peer-reviewed publications. She partners with and advises professional, advocacy, and governmental organizations to advance the equitable care of all pregnant and postpartum</p>

individuals. She serves her profession nationally as the Society of Academic Specialists in General Ob/Gyn's (SASGOG) President Elect, on the Alliance in Innovation in Maternal Health's (AIM) Perinatal Mental Health and Postpartum Discharge Transitions Safety Bundle Work Groups, on the American College of Ob/Gyn's (ACOG) Maternal Mental Health Expert Work Group (Co-Chair) and Clinical Practice Guidelines OB Committee, and as an American Board of Ob/Gyn (ABOG) oral examiner.



Nancy Byatt, DO, MS, MBA, FACLP

Dr. Byatt is a perinatal psychiatrist and physician-scientist focused on improving systems of care to promote the mental health of parents and children. Her passion is deeply rooted in her experiences as a clinician, researcher, daughter, and mother. She is a Professor with Tenure of Psychiatry, Ob/Gyn, and Population and Quantitative Health Sciences at UMass Chan Medical School. She developed the Massachusetts Child Psychiatry Access Program (MCPAP) for Moms. [MCPAP for Moms](#) is a statewide program that has 1) increased access to mental health care for thousands of perinatal individuals 2) become a national model for perinatal mental health care, and 3) impacted state and national policies and funding. She is the Founding Executive Director of the Lifeline for Families Center and [Lifeline for Moms](#) Program at UMass Chan Medical School. The Center's activities include capacity building, consultation, and research. Dr. Byatt's research uses implementation science methods to design, implement, and evaluate scalable approaches for improving parental and child mental health services and outcomes. With over ten years of continuous federal funding for her research, Dr. Byatt's achievements have led to over 90 peer-reviewed publications and book chapters, over 250 presentations, and numerous national awards.



Kate Boydston

Kate Boydston is a wife, mother, maternal mental health activist, 2023 New York Mother of the year and the 2022 Mrs. New York American. She is also a full-time educator and obtained her master's degree in special education.

Kate's mission has been to share her platform #momsmaketime and to promote and facilitate high quality, comprehensive perinatal mental health care for women in America and around the world.

Kate has partnered with Mom Congress, MoMMA's Voices, and the Postpartum Resource Center of New York to help spread her message and advocate for safer outcomes for both women and their children alike. "Seventy percent of women will hide or underplay their illness - that needs to change, we absolutely must break the stigma surrounding motherhood and mental health," she says.



Amy Ushry, RN, MPH

Amy Ushry (she/her) is a Senior Nurse Program Manager. She supervises the Collaborative Health Innovation Strategies (CHIS) department. The CHIS department supports AIM-aligned, grant-funded projects focusing on maternal mortality and severe maternal morbidity, substance use disorders in pregnancy, health equity, and respectful care.



David Laflamme, PhD, MPH

Dr. David Laflamme is the consulting epidemiologist for the Alliance for Innovation on Maternal Health. He served as the New Hampshire State Maternal and Child Health Epidemiologist for 18 years while a University of New Hampshire faculty member with the Institute for Health Policy and Practice. In addition, he taught public health graduate courses such as Social & Behavioral Health, Evaluation in Public Health, and Quality Improvement in Public Health. Dr. Laflamme holds an MPH from the Tulane University School of Public Health & Tropical Medicine and a PhD from the Johns Hopkins Bloomberg School of Public Health.

Izzy Taylor (she/her) is AIM's Data Program Supervisor. She is responsible for the overall development and management of AIM's data program to support data-driven quality improvement, reporting, and systems learning.
